## 115. Play Area Tenders

**RECOMMENDED** that Hags-SMP be appointed as the preferred contractor for the play area upgrades of Camden Close (£25,000) and Middleleaze/Saltway (£80,000) and Sutcliffe Play South West be appointed as the preferred contractor for the play area upgrades at Clayhill Copse (£25,000) and Claypits (£25,000) with installation instructed for Autumn 2018.
