Presentation: Mr Angus MacPherson, Police & Crime Commissioner, Wiltshire & Swindon

Mr Macpherson gave a presentation setting out the work of the police service in recent months including the resources associated with the Salisbury and Amesbury incidents. Mr Macpherson answered questions about the police service and reported that speeding, drugs, and anti social behaviour were important issues. Mr Macpherson reported on the growth in the numbers of police community support officers in Wiltshire and Swindon. Visibility of police locally and at public meetings was discussed. Mr Macpherson suggested that a police representative could attend the Full Council meeting bi-monthly. Residents were encouraged to sign up to community messaging <https://www.wiltsmessaging.co.uk/>. The Chair thanked Mr Macpherson.

Resident submitted a list of questions. Chair advised that these would be responded to in writing directly.

Resident asked for an update on volunteers and parking/litter enforcement. The Parish Manager advised that discussions were underway but a date for training had not been agreed due to very limited interest in participating from other Parish Councils.

152. Update from Parish Council Chair

The Chair reported that there had been discussion with a number of residents with a range of concerns such as graffiti, littering and payments to Swindon Borough Council. Some liaison with other Parishes regarding the grounds maintenance future arrangements but still trying to work through the negotiations.

153. Update from Swindon Borough Councillors

Cllr M Martin reported that since the work was continuing at Mannington Roundabout with the additional slip road from Great Western Way on to Wootton Bassett Road. The final stage would be the exit slip road from the retail park on to Great Western Way avoiding Mannington Roundabout. Cllr M Martin updated that Swindon Borough Council had launched a consultation on its draft waste and recycling Strategy. The current waste to energy plant at Waterside is very effective however changes to the export of plastic waste were impacting on local authorities across the country. The consultation sets out a summary of the issues and residents are encouraged to give their feedback. Options include separate food recycling and no separated plastic recycling.
