Public Participation:

Resident reported concern that the boundary area around the old windmill hill school site is targeted for litter and flytipping. There is also waste inside the fenced area. This is private land so is not tackled by the Parish team and has been going on for a long time and needs both enforcement and a clean up. The Chair noted the feedback.

Resident reported that the post office staff regularly drop rubber bands in the street whilst unwrapping mail. The area manager has indicated that this will be raised with the postal team.

The Chair indicated that the Parish Council had not raised any objections to the original application so it was unlikely to be raising objections this time however this would be debated as part of that agenda item.
