Presentation: Glynis Hales re: Ecofest

Resident Glynis Hales reported that following the volunteer meeting in December, conversations had taken place amongst local groups resulting in a proposal to have an Ecofest event on Saturday 3 June. This will be a joint collaboration with Savenake Community Centre Association. A venue is being established for the event in West Swindon. It is envisaged that there will be a two site approach with the engineering and mechanical side of sustainability featuring at Savenake St and the green, outdoor side in West Swindon. Music, talks and stalls are planned. Possible community growing starter packs to be distributed. Further details to be confirmed. The Chair thanked Glynis for her presentation.

The Chair shared a communication from Peatmoor Woodland group to say that community tree planting in Peatmoor by Fovant Close is planned for Sunday 5 Feb from 10.00 am to 1.00 pm. All welcome.

189. Allotments Update

The Parish Manager advised that three plots were in the process of being let to new tenants indicating on average a two year wait for a plot. Soil sample for the extension has not been finalised. It is proposed to remove the metal mobile on the allotment site as this is not in use. The Committee agreed that low cost removal

could be actioned. The area could then be upgraded to a community growing area with poly tunnel/greenhouse. Update to a future meeting.

190. Communications Update

 Parish Council was created. Cllr Gattapur volunteered to liaise with the
 family.

RESOLVED that the Parish Council commits to a commemorative bench being installed at an appropriate location.
