The Chair opened the meeting and welcomed those attending.

309. Declarations Of Interest & Applications For Dispensation

None submitted as required by the Code of Conduct adopted by the Parish Council on 24 May 2021.

310. Hedge and Shrub Maintenance Update

The Parish Manager reported that despite many disruptions created by contractors such as City Fibre, the team were nearing completion of the routine annual hedge and shrub maintenance. There are signs that birds are nesting early this year so there will be no more large scale work. The Parish Manager advised that observing the nesting period should apply to the workforce and volunteers. Care must be undertaken to check for any signs of nesting and avoid work if this is the case. More generally, it is wise to keep pruning, cutting and clearing activity to a minimum as much as it is practical to do so. There are some projects for significant reduction that will be put on hold until the summer.

311. Shaw Ridge Tree Planting

The Parish Manager advised that tree planting on Shaw Ridge would commence during March. The locations of tree planting as part of the *Trees for Climate Change* programme have been reported previously and appear as **Appendix A** in the Minute Book. Tree species include oak, willow, birch, rowan, cherry and crab apple. Any Councillors interested in getting involved are welcome to so.
