6.32 pm Public Questions: Cllr T Philpot chaired this session.

Resident asked if verges would be reinstated properly after the works by Scottish and Southern. *Cllr Ali advised that the Cabinet Member for Highways at Swindon Borough Council would be looking into it.*

Resident asked if anything could be done to create a weight restriction on Whitehill Way due to volume of noise and road conditions worsened by volume of HGV traffic. *The Parish Manager was requested to contact Swindon Borough Councillor Chris Watts*.

A resident reported obstructive hedging on Tallis Walk. To be investigated.

A resident asked if new Parish Councillors will be claiming an allowance and if Parish Councillors are on more than one Council, will they be declaring all the allowances that they collect. *Cllr T Philpot advised that allowances were provided to ensure that no Councillor would be out of pocket from fulfilling their public duties and that it was a personal decision whether or not the allowances were claimed.*

A resident asked when the pathway from the Prinnels to Shaw Ridge would be reinstated. The Parish Manager advised that this was a commitment made by a Swindon Borough Council Officer but could be followed up by the Parish team.

A resident asked why mowing was being undertaken so close to the pond area instead of

leaving distance for wildlife. The Parish Manager to investigate.

A resident asked the Parish Council to consider adding play equipment to the Prinnels area to reduce the numbers of children playing in the street. *Cllr T Philpot advised this could be considered in the future.*

Cllr Wilson reported that he wished to thank Cllr Sydney Smith for her work as a Borough Councillor for Lydiard and Freshbrook.

Cllr Ali reported that he was looking forward for all Councillors to be working together to make a difference.

21. Update from Parish Councillors

Cllr T Philpot noted that Freshbrook Coronation party did not go ahead due to the brewery pulling out and thanked resident Geoff Gould for his efforts.

Cllr Gattapur reported that Coronation activity in Westlea park went well and thanked the efforts of Ian and Fay Howard.

Cllr Singh reported that residents in the Prinnels and Ramleaze had enjoyed the Coronation. She flagged the volume of trip hazards throughout Ramleaze due to root damage to footpaths. She indicated that it was perceived that anti social behaviour is on the increase.

Cllr Sydney Smith thanked the Greendown Copse group for their work on relaying the bark footpaths through the woodland. She suggested that further work needed to be undertaken by the Parish Council in relation to youth support.

22. Mini Forests Proposal

Councillors noted information circulated relating to Tiny Forests projects which have been undertaken in other parts of Swindon.

RESOLVED that West Swindon Parish Council agrees in principle to participation in Earthwatch Tiny Forests project
