# 210. West Swindon Parish Council - Precept 2024 - 25

Councillors considered a report setting out a budget proposal for 2024-25, a copy of which appears as **Appendix B** in the Minute Book. Councillors debated the budget proposal which set out funding for a 20% increase in the overall precept demand. The Parish Manager advised that running costs had increased over time and provision needed to be made for changes in vehicle lease prices and future premises.
